

-Install under or adjacent to a Type 2 hood system for evacuation of the smoke. Flexible vent is provided if smoke is adjacent to the hood.

-Provide clearance for removal of smoke generator and access to the electric control panel.

-To prevent accidental movement, Lock caster (two caster are locking) when plugged into power. -Install on a level and non-combustible surface.
